Nominations have been received from the membership for this position, and the election will take place at the Utah ABPA Annual Conference on February 6, 2015 located at the Loveland Living Planet Aquarium in Draper, Utah. Ballots are not needed this year because Region 3 and Region 5 are Unopposed Nominees and Region 1 is an Incumbent Region Director.



Kurt McFarlane Unopposed Nominee

Kurt McFarlane was born on July 1, 1966. He has been married for 30 years to Kehli Berensen McFarlane. Together they have four children; three daughters and one son. They also have four grandchildren with another on the way.

Kurt has worked for Price River Improvement District for over 30 years and has been involved in the backflow program for about 25 of those years. Incumbent




